Priti Patel MP is a British member of parliament and the government's incumbent Home Secretary. She is also a facilitator of international terrorism - allowing the financiers of 9/11 terrorist Khalid Sheikh Mohammed (KSM) free rein to operate from their London headquarters Longulf Trading.

I know of Longulf Trading's terrorism links because in April 1997 I met their executives in Chicago when they were buying printing machinery to furnish Khalid Sheikh Mohammed's front company in Yemen. I was also the technician sent to Yemen in September 1997 to install that machinery. KSM's front company was located inside the Hayel Saeed Anam (HSA) Group's headquarters compound at PO Box 5302 Taiz. Longulf Trading is a subsidiary of the HSA Group, its London office, opened in 1977.

In October 2019 I wrote to the British Home Office to inform them that Longulf's terrorist activities were being deliberately ignored by British police. I advised her specifically that Greater Manchester Police were actively protecting Longulf Trading from investigation:

Ms Patel's Home Office reply can be summarised as "*not our problem*". The British Home Office refused to investigate allegations of police corruption, protect those who provided material support to terrorism.

Thank you for your email of 24 October to the Home Secretary. As I hope you will appreciate, the Home Secretary receives a large amount of correspondence and is unable to reply to each piece individually. Your email has therefore been forwarded to the Direct Communications Unit and I have been asked to reply.

I should explain that the police are operationally independent of Government, and that it would not be appropriate for Ministers or officials to comment on, or intervene in, a specific case, investigation or complaint. This is to ensure the police can carry out their duties independently and make decisions free from political influence.

The best way to make a complaint is to contact the police force involved. Police force

The British Home Office, under Priti Patel's command, thinks that a British police force protecting terrorist financiers by fabricating allegations against whistleblowers does not fall under her responsibility. I disagree and believe that action makes Ms Patel guilty of both misconduct in public office and of facilitating international terrorism - specifically the financiers of 9/11 terrorist Khalid Sheikh Mohammed.

Also on November 5th 2019, the date of Patel's Home Office's reply to me, the BBC published this story about secret orders that allows British security services to direct their 'informers' (mostly criminals) to commit the most serious of crimes, including murder, without having to even refer the matter to the British judiciary:

And it was Priti Patel who within a year of my correspondence with her Home Office decided to enshrine in law the power of our security services to authorise criminals under their control to commit crimes up to and including *murder*:
